RECRUITMENT OF CERTAIN VACANT POSTS ON CONTRACT BASIS IN RASHTRIYA BAL SWASTHIYA KARYAKRAM (RBSK) UNDER NATIONAL HEALTH MISSION (NHM)

1. Applications are invited from eligible candidates in the prescribed "Application Form" for recruitment of certain vacant posts on contract basis in Mobile Health Teams in RBSK Programme of National Health Mission Scheme. The contract is initially for a period of one Year and renewal will be as per the need and NHM yearly plan (PIP) and also subject to satisfactory performance. However, every year new contract has to be signed and valid for the period as indicated in the contract.

2. The Format of Applications may be downloaded from the District Official website(www.mancherial.telangana.gov.in) after filled it may be submitted in person or by Registered post to O/o the Dist. Medical & Health Officer, Mancherial. The date of receiving applications commences from **02.11.2017 at 10.30 A.M.**, and ends on **10.11.2017 by 5.00P.M.** The Selection committee is not responsible for any postal delays.

4. **EDUCATIONAL QUALIFICATION:**

5. Age:

The minimum age is **18** years, and maximum age is **44** years shall be reckoned as on 01.07.2017 for recruitment of Paramedical Posts on contract basis with the following relaxations allowed for reckoning the maximum age limit as per rules:

- i) For SCs., STs & BCs 5 (Five) years
- ii) For ex-service men 3 (three) years in addition to the length of service in armed forces.
- iii) Disabled persons 10 (ten) years.

6. Rule of Reservation:

The Rule of Reservation to Local candidates is applicable as per Presidential order, and posts shall be filled among the candidates who belong to the state of Telangana only.

7. METHOD OF RECRUITMENT

Recruitment shall be made by the District Selection Committee for the District Health Society.

Selections shall be made based on following criteria:

- a. Total Marks are 100 of which 90 marks will be allotted basing on the marks obtained in qualifying examination and 10 marks will be awarded for the age. Weightage for age will be reckoned from 18 years of age of the candidate. 0.5 marks will be awarded for one completed year of age with a maximum of 10 marks. The age will be reckoned as on 01.07.2017. (Example 1. If a candidate completes 20 years as on 01.07.2017, he will be awarded 1.0 mark; Example 2. If a candidate completes 30 years of age as on 01.07.2017, he will be awarded 6.0 marks; Example 3. If a candidate completes 40 years of age as on 01.07.2017, he will be awarded 10.0 marks).
- b. Merit list will be prepared based on the marks obtained excluding marks for languages with above criteria and displayed on website for transparency.
- c. Selection list will be prepared from the finalized merit list duly following the rule of reservations and presidential order.

8. HOW TO APPLY:

- a. Application forms along with the instructions can be downloaded from official website www.mancherial.telangana.gov.in.
- b. Filled in application form shall be submitted in person or through registered post to O/o the District Medical & Health Officer, Mancherial. Applications which are received after due dates will be summarily rejected. District Selection Committee is not responsible for postal delays.
- c. Application / Registration fees to be paid in form of **Demand Draft (DD)** in favour of **Dist. Medical and Health officer, Mancherial** as detailed below:
 - i) Application / Registration fees of Rs. 200/- for Pharmacist cadre, and 500/- for Medical Officer (MBBS) cadre in form of DD.
 - ii) The Application / Registration fees are exempted for the SC & ST Candidates.
- d. **Self-attested copies** of the following certificates should be enclosed along with the Application form should be orderly.
